

# SIMPLE WAYS TO MAKE YOUR LEGACY

# A LEGACY GIFT IS A LASTING GIFT OF GRATITUDE...

So it is important to take time to make a prayerful and thoughtful consideration of the legacy you would like to leave. Individuals of all income levels make planned gifts to accomplish their charitable purposes. This type of gift speaks to intention and generosity more than net worth. All bequests can be distributed as either a percentage or a specific dollar amount. Here are several ways to make a legacy gift:

- A. Making a Bequest in your Will or Trust:
- B. Naming the Church as a Beneficiary of a Life Insurance Policy
- C. Naming the Church as a Beneficiary of a Retirement Account
- D. Naming the Church as a Remainder Beneficiary of a Charitable Gift Annuity, Charitable Lead Trust, or Charitable Remainder Trust: These types of gifts give the donor guaranteed lifetime fixed income payments as well as offer significant tax savings.
- E. Giving Cash and Publicly Traded Securities: These types of gifts provide a tax deduction and are easy to make if you have liquid assets that are not needed now.

#### LEGACY GIFTS WILL BE USED TO SERVE THE NEEDS OF ASCENSION

Church of the Ascension has established an Endowment Fund, which consists of two sub-funds: the Permanent Fund and the Flexible Fund. The proceeds of both funds are placed in funds managed by the Colorado Episcopal Foundation. The Endowment Committee, with oversight from the Vestry, manages the percentage of allocation in each fund. The Permanent Fund's annual spending is capped at 4% to preserve the principal. The Flexible Fund can be drawn from when deemed appropriate by the Vestry. Both funds are carefully invested, and accumulated earnings are used for Ascension's ministry and building needs.

To make a legacy gift, complete the Enrollment Form available from the Parish Office and return it in person or by mail to the Parish Office. This notification will enroll you in The Ascension Legacy and place your name with others who leave legacy gifts to Church of the Ascension.
